Help Needed for Asylum Seekers | From Jessie Freer Walters

I'd like to make a plea for the folks of North Valley to take action against the Trump administration's attempt to gut the asylum system. Unfortunately, I'm not being the least bit dramatic when I say this recent proposed rule change to the way asylum law is enforced would lead to a near-complete breakdown of the asylum system, leaving people seeking asylum with little to no chance of actually being able to gain this status and remain safely and legally in the United States. But we can do something to try and stop this rule from going into effect!

The human beings this proposed rule impacts are fleeing persecution and I hold some of their stories as the attorney fighting for them. This rule is inhumane, racist and cuts against the ideals this nation should be building on. It goes against the calls we have taken up as Christians, to care for the least of these, to welcome the traveler, to care for the refugee. I do believe the people of North Valley can make a difference in this fight if they choose to take the time. As we have all struggled to know what to do next, I can offer a direct action people can take that we hope may impede this terrible change from taking place. The law requires any rule changes to be open to public comment. The U.S. Citizen and Immigration Services is required to read and address EVERY SINGLE COMMENT they receive. If we can flood USCIS with unique, thoughtful comments, we hope to slow the process down enough for a new administration to take over and throw this rule in the fire. I'm attaching a variety of resources that people can use to guide them in writing a comment and educating themselves about asylum and why it is important that we fight against this rule change. I know people have so much on their mental/emotional plates these days, but the Trump administration is counting on Americans ignoring the dismantling of the immigration system and the people this rule impacts desperately need us to pay attention to this issue. Please let me know how I can help in spreading this message and if I can offer any more information or clarification.
